## Notice Regarding Organizational Changes and Appointment of an Executive Officer

TOMY Company, Ltd. (the "TOMY") hereby announces that it has passed a resolution to conduct organizational changes and the appointment of an executive officer as described below at the Board of Directors meeting held on December 9, 2025.

### 1. Details of Organizational Changes

TOMY is promoting its business based on the management strategy of expanding its regional axis and age groups as set out in the "Medium- to Long-Term Management Strategy 2030" it has announced.
